The statement "This study aims to evaluate..." is clear, but the sentence preceding it is dense with references. Break it into two sentences: one describing the model by Madadi (2021), and another introducing the research aim.

In the sentence "30 couples were randomly selected through convenience sampling", the phrase is contradictory. Convenience sampling is non-random. Please clarify whether the selection was random or convenient.

The term "cognitive sets" is used without definition. Define or briefly explain this cognitive psychology term for clarity, especially for interdisciplinary readers.
