

## 1.1. Reviewer 1

"The (process value network) was identified as the most influential component of the regional policy-making ecosystem for the Ministry of Health and Medical Education of Iran." - The term 'process value network' should be defined more clearly. Providing a detailed description or example would help readers grasp its significance and application.

"These factors influencing the regional policy-making ecosystem for the Ministry of Health and Medical Education of Iran may lead to further development and success of this organization." - Consider discussing how these factors compare to those identified in other countries or contexts. This comparative analysis could provide deeper insights into the unique challenges and opportunities in Iran.

"Health system reform as a strategic issue worldwide involves making sustainable and targeted changes to increase efficiency equity and effectiveness in the health sector." - The phrase "strategic issue worldwide" would be more impactful with examples from specific countries or regions that have undergone significant health system reforms.

"In this study qualitative data is first collected based on the grounded theory research strategy followed by quantitative data collection using the survey research strategy." - It would be beneficial to provide more details on how the grounded theory was applied, including the specific steps taken to ensure the robustness of the qualitative data analysis.

The table presents various factors but lacks a clear explanation of how each factor was derived from the data. Including a brief description of the coding process and how these factors emerged from the data would enhance transparency and reproducibility.

"This stage involved distilling and summarizing the vast amount of information obtained from interviews and documents into concepts and categories that are similar in these questions." - Consider providing an example of how raw data from interviews was transformed into concepts and categories. This would help readers understand the analytical process better.

"Due to the lack of regional planning many health and medical resources have not been identified or utilized." - This statement would benefit from specific examples or case studies that illustrate the consequences of inadequate regional planning. Such examples could make the argument more compelling.

The figure is crucial for understanding the study's findings, but it would be more effective if accompanied by a detailed explanation of each component's role and its interconnections with other components.

#### 1.2. Reviewer 2

### Reviewer:

"After coding these factors interviews with experts will be conducted to identify the factors mentioned..." - The term 'coding' needs to be clarified. Describe the coding framework used and how inter-coder reliability was ensured, if applicable.

"Finally it was observed that 3 participants (15%) were between 30 to 40 years old 8 participants (40%) were between 40 to 50 years old and 9 participants (45%) were over 50 years old." - Consider discussing the potential impact of the age distribution of participants on the study's findings. Does the age of the experts influence their perspectives on policy-making?

"Therefore attention to health and efforts to maintain and improve it have always been a priority." - This broad statement would be strengthened by historical or contemporary examples of significant health initiatives in Iran or other relevant contexts.

"Unfortunately many developing and middle-income countries do not move in a coordinated and balanced manner toward the growth and development of health facilities..." - This critique should be supported by specific references to studies or reports that document these trends, adding credibility to the argument.

"This research aims to provide a model for a regional policy-making ecosystem for the Ministry of Health of Iran..." - It would be helpful to summarize the key components of this model briefly in the conclusion, highlighting how they interrelate and their anticipated impact.

"Health is a broad concept and according to the World Health Organization's latest definition health is complete physical mental and social well-being not merely the absence of disease and infirmity." - While this definition is well-known, providing the specific WHO source and year of this definition would be useful for readers.

"Following the interviews coding was conducted." - Detail the software or manual methods used for coding and how consistency was maintained across different coders or coding sessions.
