#### 1.1. Reviewer 1

Reviewer:

The introduction provides a broad overview of Multiple Sclerosis (MS) but lacks a clear rationale for selecting Acceptance and Commitment Therapy (ACT) and Transdiagnostic Therapy as the focal treatments. It would be beneficial to elaborate on why these specific therapies were chosen compared to other psychological approaches.

The explanation of statistical methods is thorough, but including a justification for choosing repeated measures ANCOVA over other possible analyses would add to the methodological robustness.

The presentation of means and standard deviations is clear, but discussing how these findings align or differ from similar studies could provide additional context.

The statistical assumptions are explained well, but consider including a discussion on the potential impact of violating these assumptions, even if they were not violated.



The lack of difference in the impact of both therapies on interpersonal guilt is intriguing. Discussing potential confounding variables or alternative explanations for this finding would be valuable.

#### 1.2. Reviewer 2

#### Reviewer:

Consider including more recent statistics or additional citations to strengthen the credibility of the statement. This could improve the comprehensiveness of the literature review.

Consider clarifying how the orientation session prepared participants for the intervention. This detail would help understand the participants' baseline readiness.

The discussion provides plausible explanations but could be strengthened by referencing more recent research or theoretical frameworks that support these findings.

The explanation of why Transdiagnostic Therapy may be more effective for emotional inhibition lacks depth. Adding a discussion on how the therapy's techniques uniquely address MS-related psychological challenges would be beneficial.
