### 1.1. Reviewer 1

Reviewer:

The sentence, "Awareness of knowledge about child development..." could be rephrased for clarity and conciseness, as "Awareness and understanding of child development..." would be more precise.

In the description of weekly sessions, elaborate on how the sessions were tailored to individual differences in parenting styles.

The phrase "recognizing the goals of misbehavior" needs further elaboration. Provide specific examples of common misbehavior goals and how they were addressed.

The statement, "Adler-Dreikurs group showed the most prominent change from pre-test to post-test," is impactful but requires evidence. Add a brief mention of supporting figures or p-values.

The ANOVA table is well-organized, but the term "Power" is used without explanation. Include a brief note explaining its significance in the study.

The limitation on follow-up duration is significant. Consider suggesting alternative methods, like periodic online surveys, to extend follow-up without logistical constraints.

Authors revised the manuscript and uploaded the document.

## 1.2. Reviewer 2

Reviewer:

The mention of "higher levels of education and income" as factors for effective parenting is relevant but lacks supporting data. Cite studies or include specific statistics to strengthen this claim.

The phrase "broad effects on both parents and children" is vague. Specify what these effects are to provide clarity.

The statement, "participants were randomly assigned to three groups," could benefit from specifying the method of randomization used, such as computer-generated or block randomization.

The data for "Parenting Burnout" and "Parental Stress" lacks a clear indication of statistical significance between groups in pre-test and post-test comparisons. Include p-values or annotations in the table.

The sentence, "The sample sizes were adequate," should include justification or reference to a power analysis to validate this claim.

The comparison between Adler-Dreikurs and schema-based parenting lacks depth. Expand on why Adler-Dreikurs was superior in parent-child interactions and explore potential cultural factors.

The sentence, "In schema-based parenting, increasing the mother's emotional intelligence..." would benefit from including specific techniques used to increase emotional intelligence.
